To Review, In accordance with the Public Records Act (PRA), Chapter 42.56 RCW, reference number **P004523-070921**:

1. Initial request for "Williams Code Violations", reference number **P004523-070921**,
Dated: 7/9/2021
2. County response: "We reasonably believe that public records (if any) responsive to this request will be available on or **before 7/30/2021.**"

It has become clear, under the Public Records Act (PRA), Chapter 42.56 RCW, that the SJ County Code Enforcement department is either unable, unwilling, or is simply obstructing our ability to gather data necessary for a current and timely San Juan County Economic Development Committee decision affecting these and surrounding properties. In the off chance that there is confusion about what data is being sought after, we will clarify.

The following properties are the **specific properties** we are looking to gather data on. We need to know what past, present, and any future code violation issues exist or are expected to arise. There is a current "STOP WORK" order on the #1 property. Clearly the resulting data requested exists. We are not interested in the County Code departments assessment or interpretation of the violations, but rather specifically what the violations are as they exist today, and what Owners have been cited for, or other formal County correspondence with said owners listed below.

Additionally, if the Code Enforcement office has recommended remediation of code violations/infractions or orders to these owners, what are those orders or suggestions. If the County Code Enforcement office is awaiting for Owner responses, what is the timeframe the Department has given to that Owner to receive those responses. Additionally, if there are already responses to the "STOP WORK" order, what those responses are to date.

This is a very simple request, where data is REQUIRED for a timely response to the EDC of our county regarding the MRLO decision. We expect a timely response to this request, as it has now been clarified, simplified and specific to the tax parcels listed below.

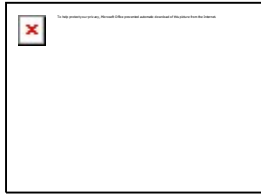
