

RESOLUTION NO. 34 - 2013

FORMATION OF A CITIZENS ADVISORY COMMITTEE TO BE  
KNOWN AS THE LOPEZ VILLAGE PLANNING REVIEW COMMITTEE WHOSE  
PURPOSE SHALL BE TO DEVELOP A SUB-AREA PLAN FOR THE LOPEZ VILLAGE  
URBAN GROWTH AREA

Background

- A. The residents of Lopez Island have contemplated and planned for growth on Lopez Island and for Lopez Village for decades.
- B. The County Council appointed a Lopez Village Ad Hoc Committee in 2009 to work toward the development of a Lopez Village Sub-Plan.
- C. Since 2009 the Lopez Village Ad Hoc Committee has undertaken a number of planning activities and completed a number of tasks but due to limited resources have yet to complete the desired Lopez Village Sub-Area Plan.
- D. The County has a strong interest in having completed a Lopez Village Sub-Area Plan and corresponding development regulations to guide development and improvements in Lopez Village.


NOW THEREFORE BE IT RESOLVED:

- A. The Lopez Village Ad Hoc Committee (2009) and its membership are dissolved.
- B. The Lopez Village Planning Review Committee (LVPRC) is established.
- C. The County Council shall appoint seven (7) citizens and/or professionals who are interested in serving on the LVPRC by a process it deems appropriate.
- D. THE LVPRC shall be responsible for making recommendations on the formulation of the Lopez Village Sub-Area Plan including but not limited to land use, capital improvements, development regulations, landscaping, parking, storm water, habitat, and pedestrian connectivity.
- E. The Community Development and Planning Department shall have the primary responsibility for providing staff support and other resources to the LVPRC. Other County departments shall also provide support as needed.
